ORDINANCE NO. 1138

**AN ORDINANCE AMENDING SECTION 4-34 OF THE CODE OF
ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING
TO PENALTIES FOR DOGS RUNNING AT LARGE..**

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Section 4-34 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

Sec. 4-34. Same - Penalty.


The penalty for permitting a dog to run at large with the city in violation of Section 4-33 is as follows:

- (1) First offense: A fine of not less than \$50.00;
- (2) Second offense: A fine of not less than \$100.00;
- (3) Third offense: A fine of not less than \$150.00;
- (4) Fourth offense and subsequent offenses: A fine of not less than \$200.00.


In no case shall the penalty exceed a fine of \$500.00 or imprisonment for a term to exceed six months, or both. The court shall have the authority to suspend any fine or imprisonment upon such terms and conditions as it deems appropriate.

Section 2. This amendment shall become effective thirty (30) days following its final passage.




