**MILES CITY, MONTANA**

**ORDINANCE NO. 1210**

**AN ORDINANCE AMENDING SECTIONS 3-59, 3-60 AND 3-61 OF THE CODE OF ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING TO THE MINIMUM AGE FOR PURCHASE OR POSSESSION OF ALCOHOLIC BEVERAGES AND MISREPRESENTATION OF SUCH AGE.**

**BE IT ORDAINED** by the City Council of the City of Miles City, Montana as follows:

**Section 1.** Section 3-59 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

**"Sec. 3-59. Sale to minors.**

No person shall sell, deliver or give away or cause or permit to be sold, delivered or given away any alcoholic beverages to any person under the age of 21 years."

**Section 2.** Section 3-60 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

**"Sec. 3-60. Purchasing or possession by minors.**

No person under the age of 21 years shall purchase or have possession of any alcoholic beverage, except as allowed by state law."


**Section 3.** Section 3-61 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

**"Sec. 3-61. Misrepresenting age for purpose of buying.**

Any person under the age of 21 years who knowingly misrepresents his age by any written card or document for the purpose of obtaining any alcoholic beverage shall be subject to the penalties provided in this article, even though the purchase and sale are not consummated."

**Section 4.** This amendment shall become effective thirty (30) days after the final passage of this Ordinance.


