ORDINANCE NO. 1211

AN ORDINANCE AMENDING SECTION 11-27 OF THE CODE OF ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING TO THE LENGTH OF THE PROBATIONARY PERIOD OF EMPLOYMENT FOR FIREFIGHTERS AND DELETING REFERENCE TO ASSISTANT CHIEF.

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:


Section 1. Section 11-27 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

“Sec. 11-27. Appointment of personnel.

The mayor shall appoint, with the consent of the council, a chief of the fire department, and all paid firefighters. All appointments shall be for a probationary term of one (1) year. If the probationary term of appointment has been satisfactory, the mayor, with the consent of the council, may make the appointment permanent, so long as the appointee is competent, maintains good conduct and is physically able to perform assigned duties.”

Section 2. This amendment shall become effective thirty (30) days after the final passage of this Ordinance.

Said ordinance read and put on its passage this 22nd day of February, 2011.




