

ORDINANCE NO. 1242

AN ORDINANCE REVISING SECTION 18-28 OF THE CODE OF ORDINANCES OF THE CITY OF MILES CITY REGARDING THE COMPENSATION OF MEMBERS OF THE MILES CITY POLICE COMMISSION; AND PROVIDING AN EFFECTIVE DATE THEREOF.

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Section 18-28 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

“Sec. 18-28. - Compensation of Members.

Each member of the police commission shall be paid *the sum of \$10.00 per day, ,but not in excess of the sum allowed by state statute*, for *each day of each-a* meeting of the police commission that such member attends in an official capacity, *such member’s compensation to be not less than \$10.00 per month nor to exceed \$50.00 per month.*”

Section 2. This amendment shall become effective thirty (30) days after its final passage.

Said ordinance read and put on its passage this 12th day of June, 2012.

7-32-4152. Term and compensation of members of police commission. (1) The appointees to the police commission shall hold office for 3 years, and one member must be appointed annually at the first regular meeting of the city council or commission in May of each year. However, a member serving on the commission during the hearing or deciding of an appeal under [7-32-4155](#) shall continue to serve on the commission for that appeal until a decision has been made; a new member may not sit on the commission for business.

(2) The compensation of the members of a board must be fixed by the city council or commission, not to exceed \$10 per day or more than \$50 per month for any month for each member in cities of the first and second class.
