

**RESOLUTION NO. 3501**

**A RESOLUTION PURSUANT TO §7-6-4006 OF THE MONTANA CODE ANNOTATED, AUTHORIZING AMENDMENT OF FINAL BUDGET FOR FY 2011-2012 TO APPROPRIATE UNANTICIPATED REVENUES TO LIBRARY GRANT FUND 2880 FOR OFFICE SUPPLIES AND MATERIALS**

*WHEREAS*, the City of Miles City has received unanticipated grant revenues in the Library Grant Fund No. 2880 in the sum of \$3,000.00,

*AND WHEREAS*, as permitted by §7-6-4006 MCA, the City of Miles City desires to amend its final budget for Fiscal Year 2011-2012 to appropriate the total amount of such unanticipated revenues in the sum of \$3,000.00 to Library Grant Fund No. 2880 for office supplies and materials;

*AND WHEREAS*, such amendment of the Final Budget for Fiscal Year 2011 - 2012 will result in an overall increase in appropriation authority in Library Grant Fund No. 2880,

*AND WHEREAS* the provisions of §7-6-4006 MCA require public hearing upon any budget amendment resulting in an overall increase in appropriation authority,

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Miles City, Montana as follows:

The appropriations for the Final Budget for Fiscal Year 2011-2012 for Library Grant Fund No. 2880 shall be increased in the following amount:


Fund No. 2880-044-460100-210 (Library Grant Fund No. 2880, Office Supplies and Materials), in the sum of \$3,000.00.

Such increased appropriation shall be made from the following Library Grant Fund No. 2880 account:

Account No. 2880-334107 - (Library Grant Fund No. 2880 - Grants) in the amount of \$3,000.00,

**BE IT FURTHER RESOLVED** that a public hearing shall be held on the above proposed amendment to the Final Budget for Fiscal Year 2011-2012 on the 26th day of June, 2012 at 7:00 p.m. in the City Council Chambers at City Hall, Miles City, Montana. The City Clerk shall cause notice of such hearing to be published in the Miles City Star, in accordance with §7-1-4128 MCA, at least 2 times with at least 6 days separating each publication.
