

**RESOLUTION NO. 3505**

**A RESOLUTION AUTHORIZING THE CITY OF MILES CITY TO ENTER INTO AN AGREEMENT EXTENDING THE TERM OF THE CONTRACT WITH DALE PETROFF d/b/a “DALE’S CLEANING SERVICE” FOR JANITORIAL SERVICES FOR CITY HALL FOR A PERIOD OF ONE YEAR.**

*WHEREAS* Dale Petroff, doing business as Dale’s Cleaning Service, of Miles City, Montana currently provides cleaning services for City Hall pursuant to a written contract with the City of Miles City that expired on June 30, 2011;

*AND WHEREAS*, pursuant to Resolution 3384 and the agreement of City and Dale Petroff, such cleaning services contract was extended for a period of one (1) year under the same terms, conditions and compensation, and that term extension will expire on June 30, 2012;

*AND WHEREAS*, the City and Dale Petroff are mutually agreeable to renewing the contract for an additional one (1) year term, from July 1, 2012 through June 30, 2013, under the same terms, conditions and compensation as the current contract between them, as more fully set forth in the Agreement Extending Term of Janitorial Service Agreement attached hereto as Exhibit “A”, and made a part hereof;


**NOW THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF THE CITY OF MILES CITY, MONTANA AS FOLLOWS:**

1. The Agreement Extending the Term of the Janitorial Service Agreement between the City of Miles City, Montana and Dale Petroff, doing business as Dale’s Cleaning Service, attached hereto as Exhibit “A”, and made a part hereof, is hereby approved and adopted by this Council.

2. The Mayor of the City of Miles City is hereby empowered and authorized to execute said Agreement Extending the Term of the Janitorial Service Agreement on behalf of the City of Miles City and bind the City of Miles City thereto.

3. The Mayor of the City of Miles City is hereby empowered and authorized to execute such further documents as are necessary to carry out the terms of said Janitorial Service Agreement and bind the City of Miles City thereto.

**AGREEMENT EXTENDING TERM OF  
JANITORIAL SERVICE AGREEMENT**
