ORDINANCE NO. 1130

**AN ORDINANCE AMENDING SECTION 22-456 OF THE CODE OF
ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING TO
THE IMPOUNDMENT OF VEHICLES ABANDONED ON CITY STREETS**

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. There is added to Subsection (a) of Section 22-456 of the Code of Ordinances of the City of Miles City, Montana a subpart (5) as follows:

"(5) When removal and/or impoundment of such vehicle is permitted by Montana statute."

Section 2. Subsection (d) of Section 22-456 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:


"(d) Before the person entitled to possession of any vehicle removed and impounded as provided in this section shall be permitted to remove the same from the custody of the municipality, such person shall furnish evidence of personal identity and of ownership of the vehicle or right of possession thereto, shall sign a receipt for the vehicle, and shall pay any towing charges incurred by the municipality together with impound storage fees of \$10.00 for each day, or fraction of a day, that the vehicle was impounded."

Section 3. Subsection (f) of Section 22-456 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:


"(f) Any vehicle left or parked on any street within the city limits for five consecutive days or longer shall be considered abandoned and shall be subject to removal, impoundment and sale by the police department as provided by Montana statute."

Section 4. This amendment shall become effective thirty (30) days after its final passage.


Said ordinance read and put on its passage this 26th day of February, 2002.


