ORDINANCE NO. 1133

**AN ORDINANCE AMENDING ORDINANCE NO. 1093 OF THE CITY OF
MILES CITY, MONTANA ESTABLISHING RATES FOR AMBULANCE
SERVICE BY THE CITY OF MILES CITY**

BE IT ORDAINED by the City Council of the City of Miles City,
Montana as follows:

Section 1. Ordinance No. 1093, passed and approved on July 28, 1998 is
amended to read as follows:

- (1) **Basic Life Support:**
 - Commencing upon the effective date of this Ordinance - \$475.00 per call (two hour maximum);
 - Commencing July 1, 2003 - \$513.00 per call (two hour maximum);
 - Commencing July 1, 2004 - \$551.00 per call (two hour maximum);
 - Commencing July 1, 2005 - \$589.00 per call (two hour maximum)

- (2) **Advance Life Support:**
 - Commencing upon the effective date of this Ordinance - \$550.00 per call (two hour maximum);
 - Commencing July 1, 2003 - \$594.00 per call (two hour maximum);
 - Commencing July 1, 2004 - \$638.00 per call (two hour maximum);
 - Commencing July 1, 2005 - \$682.00 per call (two hour maximum)

- (3) **Patient Transport Mileage:**
 - Commencing upon the effective date of this Ordinance - \$8.50 per loaded mile;
 - Commencing July 1, 2003 - \$9.20 per loaded mile;
 - Commencing July 1, 2004 - \$9.85 per loaded mile;
 - Commencing July 1, 2005 - \$10.55 per loaded mile

- (4) **Return trips from destinations out of the City (same patient or different patient):** one-half (½) of Basic Rate (no mileage charges)

- (5) **Diagnostic transfer between Miles City medical facilities (minimum two (2) hour advanced notice required. Time commences at the time for which the patient is scheduled to be transported):**
 - Commencing upon the effective date of this Ordinance - \$192.00
 - Commencing July 1, 2003 - \$207.00;
 - Commencing July 1, 2004 - \$223.00;
 - Commencing July 1, 2005 - \$238.00

- (6) **Flight Team Transportation:** - \$100.00 (arrival crew for outgoing patient or departure crew for incoming patient) Billed to transporting entity, as a flat rate fee, to pick up or deliver transporting crew and equipment to or from Miles City Airport, i.e. one way trip, pick up at airport and deliver to care facility.

- (7) **Treatment But No Transport.** \$75.00 response to emergent request, with patient assessment and treatment rendered at the scene, wherein transportation of the patient is provided by others, or declined due to patient improvement or otherwise.

(8) Disposable Supplies: Consumable supplies shall be used as needed and charged for in addition to the base charge. Supplies shall be billed at the same price as charged by Holy Rosary Health Center as of the time the supplies are utilized.

(9) Additional Miscellaneous Charges:

(a) Oxygen Administration:

For the first hour or part thereof:

Commencing upon the effective date of this Ordinance - \$40.00

Commencing July 1, 2003 - \$43.00;

Commencing July 1, 2004 - \$46.50;

Commencing July 1, 2005 - \$49.50

For each subsequent one-half (1/2) hour or part thereof:

Commencing upon the effective date of this Ordinance - \$31.00;

Commencing July 1, 2003 - \$33.50;

Commencing July 1, 2004 - \$36.00;

Commencing July 1, 2005 - \$38.50

(b) Standby for Civic Functions: \$100.00 per hour (rodeos of all types, demolition derbies, etc.)

(10) Additional Fire Department Assistance (billed on separate invoice):

(a) Apparatus: Special circumstances subsequent to E.M.S.

response, i.e.; rescue, spill control, engine assistance/extraction, scene illumination, automotive fire control, etc. with then current rates as detailed in: Northern Wildfire Coordinating Group, Interagency Incident Business Management Handbook (N.W.C.G. Handbook #2)


(b) Hazardous Materials response subsequent to E.M.S. response; Mitigation measures designed to affect the containment, control and cleanup of hazardous materials, returning the environment to its normal state. Included are flammable liquids; the neutralization, inerting and safe recovery of product; dangerous, toxic or noxious substances; transportation incidents; and processing operations. Billing shall be on a case by case basis, and shall largely encompass the rates and services as detailed in the Miles City Fire Department Standard Operating Procedures (S.O.P.) regarding the same.

Section 2. This amendment shall become effective thirty (30) days after its final passage.

Said ordinance read and put on its passage this 28th day of May, 2002.
