ORDINANCE NO. 1157

AN ORDINANCE AMENDING SECTION 12-22 OF THE CODE OF ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING TO FEES FOR APPLICATIONS FOR FLOODPLAIN PERMITS

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Section 12-22 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

Sec. 12-22. Permit Application Fee.

- (1) The following fees shall be charged for floodplain permit applications:
 - (a) Small Scale Project reviewed by Custer Conservation District under §310 of the Montana Stream Preservation Act and which qualifies for nationwide permit under §404 of the Clean Water Act - no charge;
 - (b) Mobile home \$125.00;
 - (c) Small Scale Project not reviewed by Custer Conservation District under §310 of the Montana Stream Preservation Act (e.g. placement of fill covering less than 15,000 square feet, single family residence, small pond, or other projects as determined by the Floodplain Administrator) \$250.00;
 - (d) Substantial Project. (e.g. placement of fill covering more than 15,000 square feet, stream projects not covered by nationwide permits under §404 of the Clean Water Act, gravel pits, or other projects as determined by the Floodplain Administrator) \$500.00;
 - (e) Large Scale Project. (e.g. utility substation, bridges, railroad embankment, flood control structures, golf course, commerical, industrial, multiple unit or multiple structure projects, campgrounds, or other projects as determined by the Floodplain Administrator) \$1,000.00.
 - (f) Actual fees and costs incurred by the City of Miles City for review by non-City personnel of Large Scale Projects shall be paid by the applicant as an additional permit fee.
- (2) If application for a permit is submitted after work in the floodplain has already been initiated on the project, or after completion of the project, then the permit fees set forth in subsections (1)(b) through 1(e), above, shall be doubled.
- (3) A fee of \$50.00 shall be charged for an application for extension of a floodplain permit.

- (4) A fee of \$500.00 shall be charged for each application for variance from floodplain regulations.
- (5) All fees charged hereunder shall be non-refundable.

Section 2. This amendment shall become effective thirty (30) days following its final passage.
