ORDINANCE NO. 1167

AN ORDINANCE PROVIDING A METHOD FOR PERFORMING **MAINTENANCE IN STREET MAINTENANCE DISTRICT 207** AND FOR PAYING FOR SUCH MAINTENANCE, AND **PROVIDING FOR NOTICE THEREOF**

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Definitions

- A. "Maintenance": As used herein, "maintenance" includes, but is not limited to, sprinkling, chip sealing, seal coating, overlaying, treating, pothole repair, general cleaning, sweeping, flushing, snow removal, leaf and debris removal, the operation, maintenance and repair of traffic signal systems, the repair of traffic and street signs, the placement and maintenance of pavement markings, curb and gutter repair, and minor sidewalk repair that includes cracking, chipping, sinking, and replacement of not more than 6 feet of sidewalk in any 100-foot portion of sidewalk.
- B. "Assessable Area": As used herein, "assessable area" means the portion of a lot or parcel of land that is benefited by the maintenance district.

Section 2. Method of Performing Maintenance. Maintenance within Street Maintenance District 207 shall be performed generally by forces employed by the City, or, as deemed appropriate by the City Council from time to time, by contract, or both.

Section 3. Annual Assessment for Cost of Maintenance. Such maintenance shall be paid for by annual assessment by resolution of the City Council adopted as provided for in Title 7, Chapter 12, Part 44, MCA.

Section 4. Method of Assessment of Lots and Parcels. Each lot or parcel within Maintenance District 207 shall be assessed for the cost of maintenance that its assessable area bears to the assessable area of the entire Maintenance District 207, exclusive of streets, avenues, alleys and public places.

Section 5. Notice and Hearing. The City Clerk shall publish notice, pursuant to §7-12-4406 MCA, of the introduction of this Ordinance and of the time and date it will be up for final adoption.

Section 6. Effective Date. This ordinance shall become effective thirty (30) days following its final passage.
