ORDINANCE NO. 1179

AN ORDINANCE AMENDING ORDINANCE NO. 796 TO REZONE A PORTION OF THE N½SW¼ OF SECTION 26, TOWNSHIP 8 NORTH, RANGE 47 EAST, CUSTER COUNTY, MONTANA, COMMONLY KNOWN AS TRACTS 1, 2, 3, 4 AND 5 OF THE BULL PASTURE MINOR SUBDIVISION FROM AGRICULTURAL TO LIGHT INDUSTRIAL AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS the owners of the below described real properly have made application for the property to be rezoned from Agricultural zone to Light Industrial zone;

AND WHEREAS Sec. 24-8 of the Miles City Code requires that such application be referred to the City zoning commission for public hearing and recommendation to the City Council prior to any action by the City Council upon such application;

AND WHEREAS the Miles City Zoning Commission, on February 4, 2008, held a public hearing upon the above application, pursuant to notice, and following such hearing has recommended the adoption of such zoning change;

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Ordinance No. 796 is hereby amended to provide that the following described land and property outside of the City of Miles City, Custer County, Montana, but within its zoning jurisdiction, to-wit:

Tracts 1, 2, 3, 4 and 5 of the Bull Pasture Minor Subdivision situated in the N½SW¼ of Section 26, Township 8 North, Range 47 East, Custer County, Montana according to the official plat and survey of such subdivision on file and of record in the office of the Clerk and Recorder of Custer County, Montana.


be rezoned from Agricultural zone to Light Industrial zone.

Section 2. A public hearing shall be held upon this proposed zoning changing before the City Council at 7:00 p.m. on the 24th day of June, 2008 at 7:00 p.m. at City Hall, 17 S. Eighth Street, Miles City, Montana.

Section 3. The City Clerk shall give notice of the date, time and place of such hearing by publication in the Miles City Star at least 15 days prior to the date of hearing, in accordance with §76-2-303 and §76-2-305 MCA.

Section 4. This Ordinance shall be in full force and effect thirty (30) days after its passage and approval.






