ORDINANCE NO. 1180

AN ORDINANCE AMENDING ORDINANCE NO. 796 TO REZONE LOTS 1, 2, 3, 6, 7, 8, 9, 10 AND THE WEST ONE-HALF OF LOT 4, ALL IN BLOCK 40, AND LOTS 1, 2, 3, 6, 7, 8, 9, AND 10, ALL IN BLOCK 41, OF THE ORIGINAL TOWNSITE OF THE TOWN, NOW CITY, OF MILES CITY, CUSTER COUNTY, MONTANA FROM GENERAL COMMERCIAL TO RESIDENTIAL "A" AND PROVIDING AN EFFECTIVE DATE THEREOF.

WHEREAS the owners of the below described real property have made application for the property to be rezoned from General Commercial zone to Residential "A" zone;

AND WHEREAS Sec. 24-8 of the Miles City Code requires that such application be referred to the City zoning commission for public hearing and recommendation to the City Council prior to any action by the City Council upon such application;

AND WHEREAS the Miles City Zoning Commission, on February 4, 2008, held a public hearing upon the above application, pursuant to notice, and following such hearing has recommended the adoption of such zoning change;

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Ordinance No. 796 is hereby amended to provide that the following described land and property within the City of Miles City, Custer County, Montana, to-wit:

Lots 1, 2, 3, W½ of Lot 4, Lots 6, 7, 8, 9 and 10, all in Block 40, and Lots 1, 2, 3, 6, 7, 8, 9 and 10, all in Block 41, of the Original Townsite of the Town, now City, of Miles City, Custer County, Montana according to the official plat and survey thereof on file and of record in the office of the Clerk and Recorder of Custer County, Montana.

be rezoned from General Commercial zone to Residential "A" zone.


Section 2. A public hearing shall be held upon this proposed zoning changing before the City Council at 7:00 p.m. on the 24th day of June, 2008 at 7:00 p.m. at City Hall, 17 S. Eighth Street, Miles City, Montana.

Section 3. The City Clerk shall give notice of the date, time and place of such hearing by publication in the Miles City Star at least 15 days prior to the date of hearing , in accordance with §76-2-303 and §76-2-305 MCA.

Section 4. This Ordinance shall be in full force and effect thirty (30) days after its passage and approval.






