**ORDINANCE NO. 1181**

**AN ORDINANCE AMENDING ORDINANCE NO. 796 TO REZONE LOTS 1 THROUGH 13 IN BLOCK 5, LOTS 1 THROUGH 12 IN BLOCK 6, AND LOTS 1 THROUGH 5 IN BLOCK 7 OF MILESTOWN ESTATES SUBDIVISION IN THE CITY OF MILES CITY FROM RESIDENTIAL "B" TO RESIDENTIAL "C", AND PROVIDING AN EFFECTIVE DATE THEREOF.**

**WHEREAS** the owner of the below described real property has made application for the property to be rezoned from Residential "B" zone to Residential "C" zone;

**AND WHEREAS** Sec. 24-8 of the Miles City Code requires that such application be referred to the City zoning commission for public hearing and recommendation to the City Council prior to any action by the City Council upon such application;

**AND WHEREAS** the Miles City Zoning Commission, on June 16, 2008, held a public hearing upon the above application, pursuant to notice, and following such hearing has recommended the adoption of such zoning change;

**BE IT ORDAINED** by the City Council of the City of Miles City, Montana as follows:

**Section 1.** Ordinance No. 796 is hereby amended to provide that the following described land and property within the City of Miles City, Custer County, Montana, to-wit:

Lots 1 through 13 in Block 5, Lots 1 through 12 in  
Block 6 and Lots 1 through 5 in Block 7 of  
Milestown Estates Subdivision in the City of Miles  
City


be rezoned from Residential "B" to Residential "C" Zone.

**Section 2.** A public hearing shall be held upon this proposed zoning changing before the City Council at 7:00 p.m. on the 12th day of August, 2008 at 7:00 p.m. at City Hall, 17 S. Eighth Street, Miles City, Montana.


**Section 3.** The City Clerk shall give notice of the date, time and place of such hearing by publication in the Miles City Star at least 15 days prior to the date of hearing, in accordance with §76-2-303 and §76-2-305 MCA.

**Section 4.** This Ordinance shall be in full force and effect thirty (30) days after its passage and approval.

**SAID ORDINANCE READ AND PUT UPON ITS PASSAGE THIS 22ND DAY OF JULY, 2008.**




