AN ORDINANCE AMENDING SECTION 11-30 OF THE CODE OF ORDINANCES OF THE CITY OF MILES CITY, MONTANA RELATING TO THE QUALIFICATIONS OF FIREFIGHTERS.

BE IT ORDAINED by the City Council of the City of Miles City, Montana as follows:

Section 1. Section 11-30 of the Code of Ordinances of the City of Miles City, Montana is amended to read as follows:

"Sec. 11-30. Qualifications of firefighters.

The qualifications of firefighters shall be that they shall not be, at the time of original appointment, over 34 years of age, and shall have passed a physical examination by a practicing physician duly authorized to practice in this state. Such examination shall be in writing and filed with the city clerk/treasurer, and shall disclose the ability of the applicant to perform the physical work usually required of firefighters in the performance of their duty."

Section 2. This amendment shall become effective thirty (30) days after the final passage of this Ordinance.
