The appropriations for the Final Budget for Fiscal Year 2015-2016 for the Downtown Urban Renewal District Agency Fund No. 2310-383000 (101000) shall be increased in the following amount: \$12,000.00

The following budget transfers are hereby authorized:

Transfer \$2,000 from Historic Preservation 2935-11-521000-820 to Downtown Urban Renewal District Agency 2310-383000 (101000);

Transfer \$10,000 from General Fund 1000-002-521000-820 To Downtown Urban Renewal District Agency 2310-383000 (101000).

Transfer \$10,000 from Downtown Urban Renewal District Agency 2310-11-521000-820 from grant monies received, into the General Fund 1000-383000

BE IT FURTHER RESOLVED that a public hearing shall be held on the above proposed amendment to the Final Budget for Fiscal Year 2015-2016 on the 22nd day of March, 2016, at 7:00 p.m. in the City Council Chambers at City Hall, Miles City, Montana. The City Clerk shall cause notice of such hearing to be published in the Miles City Star, in accordance with §7-1-4128 MCA, at least 2 times with at least 6 days separating each publication.
