A. RESOLUTION NO. 3804: A Resolution Providing For A Capital Improvement Fund For the Ambulance Service of the City of Miles City

- ** Councilperson Galbraith moved to bypass the motion to send the resolution to finance committee for recommendation, second by Councilperson Ahner. The motion passed 8-0.
 - ** Councilperson Galbraith moved to approve the Resolution, by title only. The motion was seconded by Councilperson Gardner.
 - ** Councilperson Galbraith moved to change item 2 in the resolution to state \$24,000 instead of 3 percent, seconded by Councilperson Hollowell.

Councilperson Ahner asked if by passing the resolution would not it reduce the revenue for the ambulance fund, and felt that it would make getting the ambulance out of the red more difficult.

Mayor Grenz explained that in a couple of years the ambulance fund is going to need a new ambulance, and by approving the resolution, it would put some money into a fund to help with matching for a grant.

Councilperson Ahner asked about getting a loan, and Clerk Pearce said that she didn't think that the ambulance fund could get a loan being so far in debt.

- ** Councilperson Galbraith moved to amend her motion, to state in an amount not to exceed \$24,000 per fiscal year, second by Councilperson Hollowell. The motion passed by unanimous vote, 8-0.
 - ** Councilperson Galbraith's original motion passed as amended by a vote of 7-1, with Councilperson Ahner voting no. Resolution No. 3804 passed with changes.

NEW BUSINESS

- A. **RESOLUTION NO. 3806**: A Resolution Authorizing The City of Miles City To Contract with Dennis Hirsch for Building Inspection Service for Fiscal year 2015-2016
- ** Councilperson Galbraith moved to pass the Resolution by title only, seconded by Councilperson Gardner.
 - ** Councilperson Hollowell moved to strike Uniform in section one, and replace with International Building, seconded by Councilperson Brush. The motion passed 8-0.
 - ** Councilperson Ahner moved to add a section d in section two of the contract to state, "Issuance of a building permit prior to Site Plan Review approval, when required, shall result in forfeiture of Inspector's fee for said permit, which shall be retained by the City, seconded by Councilperson Brush. After a long conversion the motion passed 7-1, with Councilperson Galbraith voting no.
 - ** Councilperson Galbraith's original motion to approve Resolution No. 3806 passed as amended on roll call vote 8-0. **Resolution No. 3806 passed as amended.**
