APPROVAL OF PRIOR MEETING MINUTES

No quorum so no approval of minutes.

OLD BUSINESS

Agri Industries Inc /Irrigation Project Feasibility

- Doug Phair visit with Vince Muggli regarding the irrigation property and he seems was very much in favor of it.
- Doug Phair has no reports from Mike Arnes or Bill Derosier regarding. Agri Industries income projection regarding a
 more detailed 5 year plan, cost estimate, production estimates, grant funds available, and available funds in loans.
 (DNRC Loan and if there are limits to the loan), and MDU getting electricity for the irrigation.
- Jeff Langkau reported Fort Keogh would be very receptive to an easement if they could get water to two stock tanks.
 Jeff Langkau will be working with Bill Derosier to map out an infigation route.
- * Review of the Airport Maps produced question regarding including more property in the irrigation project. Jeff Langkau will check with the DEQ & USDA for Grant Funds or Low Interest Loans regarding water and fencing. Spring Water Development maybe a possibility on some of the property where there is a spring on airport property.

MT DOT Pit Lease

• Emailed from Walt Kerttula with a counter offer to amend the current lease to \$600 annually for the remainder of the lease to June 24, 2024. After discussion with the member it was felt accepting the offer is in the best interest of the Airport. Doug Phair and Jeff Langkau will work on an amendment to the present lease including the new lease price, FAA required Subordination Clause, and an Escalation Clause of no more than 5%.

USDA-Midrivers Program for Grant Funds to build new hangers

 Doug Phair has no further information regarding any funds available with grants for building new hangers at the airport through the USDA-Midrivers Program. Doug will follow up with Midrivers regarding the program.

Land Lease or Purchase (Ben Holman)

• Jeff Langkau and Doug Phair will come up with a lease for the \$500 annually over 20 years with an Escalation Clause.

The lease will require a property description but until the property is sold a survey should not be needed. Ben Holman is getting ready to have the road put in to the property.

STAT Project Ambulance Service (Coop Airline STAT Air)

- Chairman Doug Phair reported the fund raiser event a St Vincent's he attended and requested information regarding with the STAT Project was met with a less than positive attitude.
- Doug Phair will get more information about specialized service provided by STAT Project which is needed by the hospitals.

Second Jet A Tank

• The Airport Board requested Jeff Langkau get bids for cost of a 12,000 gallon coated tank for a second tank for Jet A Fuel to purchase and store fuel when prices are lower.

Pit 57 Reclamation (Prince Inc)

• City of Miles City has had Prince Inc completed the required open cut mining reclamation required to pull material out of the wet lands and complete a burr for drainage.

New Hanger Discussion

 Add new hanger discussion to next meeting. Discussion regarding size of hanger for better use of space and cost to put up. Doors on both ends for longer building. Doug will bring designs for next meeting. What size of building requires Sprinkler System will be needed.
